

Disposition for Care Plans

When Care Plans are created, by default the Disposition is set to “Activated”. However, when a care plan is closed, the Disposition must be selected from the dropdown menu.

This information is included in the quarterly report to the California Department of Aging (CDA) in the Enrollment File.

If there is a mismatch in the Disposition field and the End Date, then it will trigger an error in the quarterly reporting. There are two types of disposition mismatches:

1. End date in the Care Plan, but disposition shows Active.

This usually occurs when the user has deleted the end date, but neglected to change the Disposition back to Activated.

Resolution: Change the disposition back to Activated, however, the best practice is to **create a new care plan and not re-open a closed care plan.**
